CLEANSING NOTICE

On 27 and 28 December 2017, Crusader Resources Limited (ASX: CAS) (**Company**) issued 41,972,784 fully paid ordinary shares to participants in the placement announced on 20 December 2017.

The Company gives this notice under section 708A(5)(e) of the *Corporations Act 2001* (Cth) (**Corporations Act**) that:

1. The above mentioned shares were issued without disclosure to investors under Part 6D.2, in reliance on section 708A(5) of the Corporations Act.
2. The Company, as at the date of this notice, has complied with:
 - (a) the provisions of Chapter 2M of the Corporations Act as they apply to the Company; and
 - (b) section 674 of the Corporations Act.
3. As at the date of this notice, other than as set out below, there is no excluded information within the meaning of sections 708A(7) and (8) of the Corporations Act which is required to be disclosed by the Company.

The Company announced on 2 August 2017 that it had signed a conditional sale agreement to divest its 100% interest in the Posse Iron Ore Mine to Inter Invest B.P. S/A (**Inter Invest**) (**Sale Agreement**). The Sale Agreement provided for a total consideration of R\$8.005M (~A\$3.2M¹), to be paid over a 17 month period. As at the date of this notice,

Inter Invest has paid R\$1.25M (~A\$500k¹) of this consideration, and R\$1.39M (~A\$556k¹) is overdue.

The Company and Inter Invest are presently in negotiations with a view to reaching an agreement to amend the Sale Agreement. These negotiations are focused on bringing forward the total consideration allowing the company to focus all attention on its gold assets., These discussions are incomplete and confidential and there can be no certainty that any agreement will be reached, or that any such agreement reached will be completed. A further announcement will be released in due course.
